<b>Item 3:</b>	Update Pacific/Oceania Games PNG and Youth Commonwealth Games Samoa. J Moss
<b>Matters</b>	<p>JM said he was waiting for NZOC to accept the nomination criteria for Oceania Games and SCYG.</p> <p>The Long List for the Senior team for PNG has been submitted.</p> <p>OWNZ are seeking funding for a team of 51 people to attend the Pacific Games in Port Moresby, PNG 4-9 July 2015. This event is managed by the NZOC and the indicative team services fee is \$3,200 per person. The total cost is therefore expected to be 51 x \$3,200 = \$163,200..</p>

<b>Item 6:</b>	General Managers position funding application.
<b>Matters:</b>	Emma Pilkington to apply for funding to financially support her part time administration role transitioning into a full time General Managers role. Full time salary application will be for \$50,000. The application will be to the New Zealand Community Trust.

<b>Item7:</b>	Acknowledgement of TO's for Samoa Youth Games.
<b>Matters</b>	T Ebert, J Ebert, G Marshall and K-D Soffe all approved by IWF to officiate at the 2015 Commonwealth Youth Games, Samoa.
	The EG congratulated the TO's on their International appointment.
<b>Item 8:</b>	Payment of referees IWF licences for 2015 upgraded referees.
<b>Matters</b>	Logan Taylor FSO now Level 1 referee.
<b>Decision or Recommendations</b>	After discussion it was agreed unanimously that OWNZ would pay for the new licences.
<b>Item 9:</b>	2017 WMG committee minutes which included \$250 to the 2015 OWNZ National Masters winners – Queenstown. Based on best masters formula winners.
<b>Matters</b>	
<b>Decision or Recommendations</b>	It was agreed that the EO forward the 2017 WMG committee minutes to all EG members and the Administration Officer.

<b>Item 10:</b>	Intention to remove Level 2 referees from register if they haven't refereed in the last 12 months. G Marshall.
<b>Matters</b>	GM supplied the EG with a list of all OWNZ Level 2 referees who had not refereed during the last 12 months and who had not affiliated for 2015.
<b>Decision or Recommendations</b>	.It was agreed that the Referees Examiner should remove all the above referees and inform them that if they affiliated and registered by March 31 they would be reinstated.
<b>Item 11:</b>	<p>Questions from Marie Soffe. Can she pay her affiliation directly into the OWNZ bank a/c?</p> <p>Can someone else complete her registration and payment?</p> <p>Is there anything in the OWNZ Bylaws that would prevent someone else doing the above?</p>
<b>Matters</b>	All questions had been answered.
<b>Decision or Recommendations</b>	It was agreed that no further action was required.
<b>General Business</b>	<p>JD asked about the status of Guest lifters at the OWA Championships – eligible to compete but not eligible to compete for medals or championships.</p> <p>JM expressed concern regarding the change to details of the Mainland Head2Head competitions. It was agreed that the Mainland Head2Head competitions be removed from the OWNZ Calendar and that CCW apply to the April EG meeting for approval of their contests, giving details of the participating clubs and competition structure.</p> <p>RP commented on the use of Social Media which often had statements which did not reflect positively on OWNZ.</p> <p>GM raised the question of the option for members to download records and gradings from the website for posting on gym walls etc.. PP stated that this was possible.</p> <p>The Oceania Elite training camp in May has been cancelled as has the Technical Seminar in Suva-April.</p> <p>GM stated that it would be in the interest of all clubs to download from the IWF website, the Technical Committees Athlete Uniform. An excellent written and visual explanation of the updated uniform regulations. Go to IWF website Home Page, Scroll down to the Downloads and go to the IWF Technical Committee – Athlete Uniform.</p> <p>Emma asked for comment regarding the Cobra Clothing sponsorship plan. After discussion it was agreed that rather than be a sponsor it may be preferable for Cobra to become a business partner with OWNZ.</p>
