The misinterpretation of this clause (they used only one level one ref for each session) unfortunately resulted in the performances from a sanctioned club contest being ineligible for inclusion in our official rankings, qualifications, etc. Consequently can you possibly request that the EG alters this clause to read: "9.3.1 At least two of the Referees adjudicating the same session at a Sanctioned Event must hold OWNZ National Level 1 status or higher." GM supports this change. GM clarified the confusion that had arisen and the need to accept Ron's correction. MR moved for acceptance, seconded GM. Passed unanimously. |
