Ray is also looking to facilitate club coaches on how they can get into schools, as Ray used to be a school teacher he understands the terminology and requirements that need to be met for schools to accept a new program. My request is to appoint Ray as the OWNZ Secondary School Coordinator (volunteer) and for OWNZ provide him with the support and resources he needs to get this underway. For example, provide him with an OWNZ email, give him access to the OWNZ logos/images for branding of the program, General Manager to look into KiwiSport funding to cover costs of school programs run throughout the country, help with partnering with potential stakeholders (sponsors, education facilitators) etc |
